This book looks at ethics in a fairly broad sense. Subjects covered include: public concern, values and codes, stakeholders, company vision, and business ethics into the 21st century. It is written in a way that is intended to help you to review the behaviour of your own organisation.

Part 4 gives practical guidance for developing and implementing codes of ethics and looks at auditing approaches adopted by companies.
